 CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive infant. The infant was transported to a local hospital where he was determined to be in critical condition. Lifesaving measures were taken; however, they were unsuccessful and the infant was pronounced deceased several hours later.
