- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

  CCDFS received a report concerning a baby who was found deceased in his mother's motel room. It was reported that relatives attempted to visit the mother in her motel room, but she would not allow them entry. They became concerned and notified law enforcement. Law enforcement and emergency medical personnel responded to the location. The mother was discovered to have given birth to twins, one of whom was found to be deceased. Concerns were noted with regard to the living environment and circumstances of the birth.
- D. The date of birth and gender of child: 5/5/2020. Male

- E. The date that the child suffered the fatality or near fatality: 5/6/2020
- F. The cause of the fatality or near fatality, if such information has been determined:

  Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this family or household:

10/14/2010 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

4/3/2014 - A referral was received and was coded "Information Only."

5/26/2014 – A report was received alleging abuse and neglect. Court action was initiated and a relevant family member was determined to be in need of protection. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. On 2/26/2015, a second report was received alleging neglect and court action was also initiated in this instance. The allegations in both reports were found substantiated. During the course of the open case, a referral was received on 2/3/2015 that was coded "Information Only". Additionally, on 2/24/2015 and 7/1/2015, reports were received alleging neglect. Upon conclusion of a requisite investigations in each instance, the allegations were found unsubstantiated. On 11/17/2015, the court terminated wardship and custody and the case closed.

4/4/2016 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

9/15/2017 - A referral was received and was coded "Information Only".

2/26/2018 – A report was received alleging abuse, with additional information being received on 3/1/2018. On 7/10/2019, a second report was opened alleging abuse following the birth of another child. Court action was initiated in each instance with the minors being determined to be in need of protection. The allegations in both reports were found substantiated. The family was placed under formal supervision and a case plan was put in place. On 8/6/2019 wardship was terminated with regard to one of the minors. On 3/26/2020, a referral was received and was coded "Information Only". Appropriate referrals and services are being provided to the family. The case remains open.

CCDFS opened a case for investigation. Family assessment remains ongoing. CCDFS will, as deemed appropriate, continue to provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
