 CCDFS received a report that law enforcement and emergency medical personnel responded to a local apartment complex on a 9-1-1 call indicating that an infant had been thrown from a second-floor apartment balcony during a domestic dispute. The infant was transported to a local hospital where she was pronounced deceased. An arrest has been made with regard to the incident.
