C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 9-19-2020 WCHSA learned of a child fatality involving a twelve-year-old minor child. The fatality was investigated as a homicide.

D. The date of birth and gender of child:

3-18-2008; Male

E. The date that the child suffered the fatality or near fatality:

9-18-2020

F. The cause of the fatality or near fatality, if such information has been determined:

The manner of death was determined to be a homicide while the cause of death is multiple sharp force injuries

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

3/14/2008- A report was received by WCHSA alleging physical abuse of a minor child by the parent. The report was dispositioned as Information Only.

12/23/2008 – A report was received by WCHSA alleging drug use and lack of supervision with respect to the parent. This report was dispositioned as Information Only.

1/1/2010- A report received by WCHSA alleging domestic violence, parental intoxication, and parental arrest. This report was subsequently investigated and determined to be Substantiated

2/4/2010- A report was received by WCHSA alleging neglect and failure to protect on behalf of the parent. This report was subsequently dispositioned as Information Only

4/24/2014- A report was received by WCHSA alleging inadequate supervision and physical risk of the minor child in the home. This report was investigated and determined to be Substantiated.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

WCHSA and law enforcement collaborated on a joint investigation on this case. There are no other children residing in the home. The parent had received supportive services through a victim advocate and resources for grief and have been be provided to the family.
