- B. Location of child at the time of death or near fatality (city/county): Washoe County
- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: The mom gave birth to the baby at home. She was not aware that she was pregnant and did not receive any prenatal care. The baby was brought to the hospital by REMSA and was in full cardiac arrest upon arrival. He also still had his umbilical cord and placenta attached. Life saving measures were attempted, however the baby's airway and mouth "were completely full of meconium". There is question whether the baby was breathing due to this fact.

There is one prior report that was unsubstantiated from 2016 for neglect failure to protect a non-related child in another jurisdiction.

Criminal investigation concluded; no charges filed. Support services were offered to the mother; however she was unwilling to engage with worker and case was closed.
