- B. Location of child at the time of death or near fatality (city/county):  
Reno/Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:  
A two week old baby boy was brought to the hospital ER by the parents for not breathing. Life saving measures were completed by the hospital. He remained in the hospital at that time.
- On 4/6/2020, the life saving measures were removed and the infant passed away.
- D. The date of birth and gender of child:  
3/18/20 male
- E. The date that the child suffered the fatality:  
4/7/20
- F. The cause of the fatality or near fatality, if such information has been determined:  
An autopsy will be completed by the medical examiners office. The autopsy is still pending at this time.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the

rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

There is one prior report to WCHSA. An information only report was received on 3-18-2020 regarding a report of a substance exposed infant. The infant tested positive for marijuana at birth. No concerns for the parents at this time as are appropriate and bonding.

Ongoing joint investigation with local LEA and WCHSA is continuing. There are no other children in the family home.
