Emergency Services were called, and the child was transported to a local hospital. Life saving measures were completed, but were unsuccessful and the infant was pronounced deceased

- E. The date that the child suffered the fatality or near fatality: November 27, 2020
- F. The cause of the fatality or near fatality, if such information has been determined: Unknown at this time.
