A report was received by WCHSA advising that an infant was found unresponsive and not breathing. CPR was performed and the infant was subsequently transported to a local hospital where she pronounced deceased.

3/19/01 – A report of lack of supervision was received by WCHSA and subsequently investigation and determined to be unsubstantiated.

10/13/05 – A report of a domestic violence incident between the parents was received by WCHSA. The report also indicated that that a minor child in the residence was also involved in the incident, but did not sustain visible injury. The report was dispositioned as information only

10/2/06- A report of lack of supervision was received by WCHSA. It was report that several minors were left with out of supervision in front of a downtown casino. The report was dispositioned as information only.

10/16/06 – A report of lack of supervision and unhealthy living conditions was received by WCHSA. This report was subsequently investigated and determined to be unsubstantiated.

3/18/13 – A report was received by WCHSA that alleged, lack of supervision of a minor child and alcohol use by adults in the home. This report was dispositioned as information only.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident.
