- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
 A report was received to Washoe County Human Services Agency regarding a 6-year-old found face
 down, unresponsive, and not breathing on a blowup mattress by his mother. He was diagnosed with
 cerebral palsy which causes him to have limited core strength and limited mobility. Life saving measures
 were attempted and not successful. He was pronounced dead at the hospital.
