The mom gave birth to the baby at home. She was not aware that she was pregnant and did not receive any prenatal care. The baby was brought to the hospital by REMSA and was in full cardiac arrest upon arrival. He also still had his umbilical cord and placenta attached. Life saving measures were attempted, however the baby's airway and mouth "were completely full of meconium". There is question whether the baby was breathing due to this fact.
