Job Description: Resiliency Center Behavioral Health Coordinator Las Vegas, Nevada

The Department of Health and Human Services is accepting resumes for the Resiliency Center Behavioral Health Coordinator in Las Vegas. This is a grant funded position using a temporary employment agency as the employer of record. Resumes will be accepted until the position is filled (open until recruitment needs are satisfied). All letters of interest and resumes will be accepted on a first come, first served basis. Hiring may occur at any time during the recruitment process.

Salary Range:

Pay range for this position is between \$34.39 per hour to \$51.95. Starting pay will be dependent on applicant's education and experience.

Objective:

The **Vegas Strong Resiliency Center** (VSRC) is a place of healing and support dedicated to serving as a resource and referral center for residents, visitors and responders affected by the shooting at the Route 91 Harvest Festival on October 1, 2017. The Center is staffed by knowledgeable and caring professionals to help people access resources to help them build strength and resiliency in the aftermath of this incident.

Services that are available include victim advocacy and support, case management, counseling and spiritual care referrals, technical assistance with applying for online services including FBI Victim Assistance services and more. The Resiliency Center Behavioral Health Coordinator is responsible for the oversight of the Vegas Strong Resiliency Center and serving those impacted by this event.

Qualifications:

EDUCATION AND EXPERIENCE: Master's degree from an accredited college or university in a social science or health-related field, which included clinical intervention coursework, and four years of professional experience in a behavioral health delivery setting including work as a clinician. One year of the required experience must have included supervision of professionals; **OR** an equivalent combination of experience and education above the master's degree level. Special Consideration will be given to persons with knowledge of evidence based and evidence informed screening, assessment tools to assist in evaluating current state of disaster related distress or symptoms of depression, posttraumatic stress or other trauma related disorders; trauma specific clinical counseling experience with traumatized, high-risk populations; Ability to establish rapport with the primary survivor as well as the entire 'team of providers' that will be working to help that survivor; and ability to provide services in home or in disparate locations. Previous grant experience of deliverables and reporting is preferred.

Qualified candidates must meet the minimum qualifications of a <u>Clinical Program Manager 3</u> as outlined by the Department of Administration.

Responsibilities:

The Resiliency Center Behavioral Health Coordinator will plan, organize, implement and direct mental health service delivery programs at the VSRC by establishing goals, objectives, policies, and procedures; monitoring and evaluating program performance; developing and monitoring budgets; integrating programs with other state and community services; and supervising clinical and administrative staff, typically including licensed Psychologists and/or subordinate supervisors of professional clinicians.

The Resiliency Center Behavioral Health Coordinator will also be responsible for allocating staff and resources; development of policy and procedures for addressing the target populations; coordination of multiple stakeholders in the community as well as across the nation; may design, coordinate, and conduct training on clinical tools, intervention models, core competencies, and improvement processes
