Melissa Washabaugh called the meeting to order at 3:01 p.m. Kary Wilder, Administrative Assistant, Division of Child and Family Services (DCFS), conducted roll call and a quorum was established.

2. **Public Comment.** No action may be taken upon a matter raised during a period devoted to comments by the general public until the matter itself has been specifically included on an agenda as an item upon which action may be taken.

Sarah Hannonen announced that Elko's High School Student Council is holding a 2023 Mental Health Awareness Week on February 6-11, 2023. She suggested the Consortium have a table at the event to help spread awareness.

Melissa Washabaugh said she received email from Dana Walburn asking for input about a grant program related to the Safer Communities Act. She said she was going to send individual feedback as a healthcare provider for the area.

Cherylyn Rahr-Wood said the Northern Rural Behavioral Health Policy Board is bringing Shannon Bennett and Cole Finney in to talk about funding streams for behavioral health on January 5<sup>th</sup> at 2:00 pm. She said this would be a good opportunity to learn more about state funding and meetings are recorded. Lana Robards said the same presentation was given at the September Advisory meeting.

Melissa Washabaugh shared a draft letter from the Consortium in support of Assembly Bill 9 which she will send to the Health & Human Resources Department after it is approved.

Michelle Sandoval said Amada Haboush-Deloye, Chair of the Clark County Children's Mental Health Consortium (CCCMHC), maintains a tracking list of legislative bills involving youth, children, and adolescents which could be reviewed at the next meeting to determine additional bills which RCMHC might want to support. She asked Kary Wilder to obtain and distribute the CCCMHC legislative bill tracking list to the RCMHC listserv.

10. For Information Only. Update on System of Care (SOC) Grant – *Bill Wyss, Division of Child and Family Services (DCFS)* 

Amna Khawaja, SOC Health Program Specialist II, gave a PowerPoint presentation with updates on the SOC Self-Directed Respite Care and Flex Funds programs. 11. Update on Pediatric Mental Health Access Care Grant (NVPeds) – *Nicole Mara, Psychiatric Caseworker II, Division of Child and Family Services (DCFS)* 

Nicole Mara reported there were 210 attendees at the November "Ripple Effect" webinar training series and more sessions are scheduled for February 23-24, 2023 (these sessions cannot be recorded per contract). She asked everyone to send her information and suggestions on additional rural-appropriate training opportunities. Michell Sandoval and Sarah Hannon will send her the information and flyer on the Elko event.

12. **For Possible Action.** Consortium Retreat Planning and Possible Vote – *RCMHC Members*

13. **For Possible Action.** Community Event Participation and Possible Vote – *RCMHC Members* 

Michelle Sandoval, Sarah Hannonen, and Heather Plager said they would attend the Elko Mental Health Awareness event on Saturday, February 11<sup>th</sup>. Cherylyn Rahr-Woods also said she would be attending the event to set up a table for mental health crisis hold and suicide prevention.

Kristen Rivas clarified that anyone wanting travel cost reimbursement needs to become established as a State Vendor and all travel costs and reimbursement need to be submitted to and pre-approved by the State Fiscal Department in advance which can take several weeks. Kary Wilder will distribute the vendor application/registration process information and requirements to the RCMHC listsery.

**MOTION:** Rebecca McGough made a motion to approve sending representatives to the Elko Mental Health Awareness event in February, 2023 and reimburse them for mileage costs.

Melissa Washabaugh said RCMHC would hold a separate event in collaboration with Nevada PEP and Youth M.O.V.E. It was decided that RCMHC would also participate in the legislative event in May with a booth, banner, and outreach/swag materials. Planning can begin when the date is published. Vanessa Dunn put a link to the legislative social event calendar in the Chat.

Kristen Rivas said there were many swag items available at the Reno office, including a supply of the popular RCMHC logo-imprinted brain stress balls.

Michelle Sandoval said work is in progress to develop the behavioral health community integration and strategic plan called the Nevada Behavioral Health Community Integration Strategic Plan (which was driven by Olmstead Plan). She said the plan is updated every couple of years and it outlines and updates resources and projects throughout the state. The report has been strongly focused on adults in the past but work is being done to integrate child, youth and adolescent mental health information. She said she was hoping RCMHC can get a presentation after the report is released in January.

Michelle Sandoval said the Division of Public and Behavioral Health, Bureau of Behavioral Health, Wellness and Prevention, and the Division of Child and Family Services are holding a Summit on Improving Community Response to Individuals with Behavioral Health Challenges on January 18-19, 2023 in Las Vegas. She will send the flyer to Kary Wilder to distribute to the RCMHC listserv. She said Dr. Stephanie Woodard will be there to present on the State of Nevada's mental health services.
