A. Date of the notification to the child welfare agency of the death of a child:

The date of this near fatality was 6/11/2013. CCDFS was notified of the near fatality on 6/11/2013 at 11:25 p.m. CCDFS was notified of the fatality on 6/13/2013.

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

Law enforcement and medical personnel responded to a local residence concerning a report of an unresponsive child. The child was transported to a local hospital where she was placed on life support. It was reported that the child sustained injuries suspicious for non-accidental trauma.

On 6/13/2013, the child succumbed to her injuries and was pronounced deceased.

D. The date of birth and gender of child: 1/19/2012, Female

E. The date that the child suffered the fatality or near fatality:

F. The cause of the fatality or near fatality, if such information has been determined:

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:** (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has no prior history for this child, her family, and/or household.

- H. CCDFS continues to investigate the near fatality/fatality and is working in conjunction with local law enforcement. Family and household assessment are ongoing. Other relevant members of the household remain placed in protective custody. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.

NON-DISCLOSURE NOTICE
