**B. Location of child at the time of death or near fatality (city/county):** N. Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

CCDFS received a report that law enforcement and emergency medical personnel responded to the local residence of the child's adult caregiver on a 9-1-1 call that the child was in physical distress. The child was transported to a local hospital where he was listed in critical condition.

On 2/5/2016, the child was pronounced deceased.

**D. The date of birth and gender of child:** 8/21/2015, Male

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

The cause of the near fatality/fatality is under investigation. Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. CCDFS has no prior CPS history for this child and/or his family, the child's adult caregiver, or the household where the child was located at the time of the 9-1-1 call.

CCDFS has opened an investigation and is working in conjunction with local law enforcement. Family assessment is ongoing.
