6/8/2016 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

6/14/2016 – The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded "Information Only".

9/30/2016 – A report was received alleging neglect. The case remains open.

CCDFS has opened an investigation and is working in conjunction with local law enforcement. Family assessment is ongoing. CCDFS will continue to, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the family and/or household.
