A. Date of the notification to the child welfare agency of the death of a child: 10/30/2016

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

Local law enforcement and emergency medical personnel responded to a local residence on a call concerning an unresponsive child. The child was transported to a local hospital where he was pronounced deceased shortly after his arrival.

D. The date of birth and gender of child: 6/17/2009, Male

E. The date that the child suffered the fatality or near fatality: 10/30/2016

F. The cause of the fatality or near fatality, if such information has been determined:
Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has the following history for this child, his family and/or household:

9/13/2011 – A report was received alleging abuse and involved a household member. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

11/13/2011 –The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded “Information Only”.

2/7/2016 – This report was referred to an outside agency for assessment through the Differential Response program.

7/20/2016 –The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded “Information Only”.

- H. CCDFS has opened an investigation and continues to work in conjunction with local law enforcement. Family and household assessment remain ongoing.
