A. Date of the notification to the child welfare agency of the death of a child:

CCDFS was notified of the near fatality on 3/5/2016.

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to the local residence of the child's adult caregivers on a 9-1-1 call that the child was in physical distress. The child was transported to a local hospital where she was listed in critical condition.

D. The date of birth and gender of child: 3/6/2014, Female

E. The date that the child suffered the fatality or near fatality: 3/5/2016

F. The cause of the fatality or near fatality, if such information has been determined:

No maltreatment was found to be a factor in this near fatality.

- G. The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has no prior CPS history for this child and/or her family.

CCDFS has one prior CPS investigation for the household where the child was located at the time of the 9-1-1 call. On 6/6/2011, a report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

- H. Whether the agency which provides child welfare services, in response to the fatality or near fatality:** (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS has concluded its investigation and family assessment. The investigation found no evidence to support that the child's condition was a result of maltreatment. There are no concerns relating to the safety of the child. No further CPS intervention has been deemed necessary and the case has been closed.
