## A. Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 3/30/2016.

**B.** Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

## C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report indicating emergency medical personnel had transported the 3month-old child to a local hospital for treatment. Upon examination, the child was determined to be in critical condition.

- E. The date that the child suffered the fatality or near fatality: 3/30/2016
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
