CCDFS has one prior CPS investigation for the family. On 5/22/2014, a report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was found not to be in need of services and the case was closed.

H. CCDFS has opened a report for investigation and family assessment and is working in conjunction with local law enforcement.
