Information for Release:

A. Date of the notification to the child welfare agency of the death of a child:

CCDFS was notified of the near fatality on 11/28/2016.

B. Location of child at the time of death or near fatality (city/county): Henderson, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child sustained injuries as a result of a car accident in which she was an unrestrained passenger. She was transported from the scene of the accident to a local hospital for treatment and listed in critical condition.

D. The date of birth and gender of child: 7/24/2009, Female

E. The date that the child suffered the fatality or near fatality: 11/27/2016

F. The cause of the fatality or near fatality, if such information has been determined:

The cause of the near fatality is under investigation.

- G. The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has no prior CPS history for this child and/or her family.
