CCDFS has the following prior CPS history for this child and/or her family:

5/3/2013 – The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded "Information Only".

12/11/2014 and 12/22/2014 – Reports was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. A safety plan was put in place. Appropriate referrals were provided, and community resources and in-home support services were put in place to address the family's needs. The case was closed 3/23/2015.

10/30/2015 – This report was referred to an outside agency for assessment through the Nevada Department of Health and Human Resources, Differential Response program.

2/24/2016 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

5/9/2016 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

8/6/2016 – A report was received alleging neglect. On 8/23/2016 and 9/27/2016 referrals with additional information relating to the report were received. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. Appropriate referrals were provided to the family and the case was closed.

10/21/2016 – The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded "Information Only".

## H. Whether the agency which provides child welfare services, in response to the fatality or

CCDFS has concluded its investigation and family assessment. The investigation found no evidence to support that the child's condition was a result of maltreatment. Appropriate referrals for services were provided to the family based on their needs. No further CPS intervention has been deemed necessary and the case has been closed.
