Information for Release:

- A. Date of the notification to the child welfare agency of the death of a child: On 4/25/2017, DFS received notification that the body of a deceased child had been located, however, the identity had yet to be determined. On 4/27/2017, the identity of the body was confirmed.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 4/25/2017, CCDFS received information that the child was reportedly missing since December 2016 and his whereabouts were unknown. A body was located and, at the time of the report, it was yet to be determined to be this child.

- D. The date of birth and gender of child: 11/17/2003, Male
- **E.** The date that the child suffered the fatality or near fatality: Currently unknown. The body was found on or about 4/25/2017.
- **F.** The cause of the fatality or near fatality, if such information has been determined: Release of the cause of the fatality will remain pending until receipt of official coroner documentation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality and the date on which the last contact or communication occurred before the fatality or near fatality;
 (2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;
 (3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;
 (4) Whether the agency which provides child welfare services took any other actions concerning the welfare of the child before or at the time of the fatality or near fatality;

(5) A summary of the status of the child's case at the time of the fatality or near fatality, including, without limitation, whether the child's case was closed by the agency which provides child welfare services before the fatality or near fatality and, if so, the reasons that the case was closed.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has the following prior CPS history for this child and/or family:

2/12/2006 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

6/8/2007 – A report was received alleging neglect. Court action was initiated and the child was determined to be in need of protection. The allegations in the report were found substantiated. The family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. The court terminated formal supervision on 12/11/2008 and the case closed.

11/15/2013 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

7/29/2014 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

12/11/2014 – A report was received alleging neglect, with a secondary report received the same date containing additional information. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

3/20/2015 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

4/9/2016 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found substantiated. A safety plan was implemented. On 4/20/2016, the child was taken into protective custody. Court action was initiated and a petition was filed. On 6/8/2016, the court dismissed the petition and returned the child to the parent; thereby closing the case as to the child.

3/30/2017 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found substantiated.

4/16/2017 – Information was received alleging that the child's whereabouts was unknown. No further information was provided and the report was coded "Information Only". The child was reported as a runaway / missing person with the appropriate authorities.

H. Whether the agency which provides child welfare services, in response to the fatality or

CCDFS has opened an investigation and is working in conjunction with local law enforcement. Family assessment is ongoing.
