Emergency medical personnel responded to the scene where a teenage boy was found shot. He was transported to a local hospital where he was pronounced deceased. The father of the child has been arrested in connection with the incident. D. The date of birth and gender of child: 2/18/2003, Male

- F. The cause of the fatality or near fatality, if such information has been determined: Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

CCDFS has the following relevant prior CPS history for this child and/or his family:

2/24/2004 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

5/11/2005 - A report was received alleging abuse and neglect. Court action was initiated with relevant family members being determined to be in need of protection. The allegations in the report were found substantiated. The case was adjudicated with relevant family members being placed under the court's jurisdiction. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. The court terminated wardship and formal supervision on 5/11/2006 and the case was closed.

2/22/2007 - A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

4/5/2013 - A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

11/10/2015- A report was received alleging neglect. Upon conclusion of a requisite investigation, one allegation was found substantiated.

4/19/2017 – A referral was received from a non-mandated reporting source. The factual circumstances were not sufficient to rise to the level of warranting an investigation. Due to the content of the information provided, CCDFS initiated a call to law enforcement for a welfare check on the family in order to ascertain the veracity of the facts. The referral was coded "Information Only."
