CCDFS has one prior investigation for this child and family. On 8/30/2017, a report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was provided with referrals to appropriate community resources and the case was closed 11/3/2017.

H.
