CCDFS received a report that, on 3/10/2017, emergency medical personnel responded to a local residence on a 9-1-1 call regarding an unresponsive child. The child was transported to a local hospital where he was assessed and determined to be in critical condition. On 3/13/2017, the child was pronounced deceased.

8/4/2009 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

11/18/2009 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

9/21/2010 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found substantiated. The family was provided appropriate referrals for services and the case was closed.
