**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

CCDFS received a report that, on 6/12/2017, the parent brought the child to a local hospital for treatment. Upon examination, the child was determined to be in critical condition. On 6/14/2017, the child was pronounced deceased.

**D. The date of birth and gender of child:** 12/3/2016, Female

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:** (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)**

CCDFS had one open case for this child and her family. On 5/17/2016, a report was received alleging abuse and neglect, and on 12/8/2016 a report was received alleging neglect. Court action was initiated in each instance with the relevant minors being determined to be in need of protection. The allegations in each report were found substantiated. During the course of the open case, the family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. The court terminated wardship and custody on 5/17/2017 and the case closed 5/30/2017.

1/27/2017 – A referral was received that did not rise to the level of warranting an investigation and was coded “Information Only”.

- H. Whether the agency which provides child welfare services, in response to the fatality or near fatality:** (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS has opened an investigation continues to work in conjunction with local law enforcement. The family continues to be assessed with appropriate services and referrals being provided as indicated.
