Upon examination, the child was determined to be in critical condition. On 6/14/2017, the child was pronounced deceased. D. The date of birth and gender of child: 12/3/2016, Female Ε. CCDFS had one open case for this child and her family. On 5/17/2016, a report was received alleging abuse and neglect, and on 12/8/2016 a report was received alleging neglect. Court action was initiated in each instance with the relevant minors being determined to be in need of protection. The allegations in each report were found substantiated. During the course of the open case, the family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. The court terminated wardship and custody on 5/17/2017 and the case closed 5/30/2017.

1/27/2017 – A referral was received that did not rise to the level of warranting an investigation and was coded "Information Only".
