A summary of the report of abuse or neglect and a factual description of the contents of the report: On 11/19/2017, CCDFS received a report that the child, who was in physical distress, was transported to a local hospital by her parent. Upon medical assessment, the child was determined to be in critical condition. The child has been pronounced deceased. D. The date of birth and gender of child: 8/19/2017, Female Ε. The date that the child suffered the fatality or near fatality: Near fatality: 11/19/2017 Fatality: 11/22/2017

F. The cause of the fatality or near fatality, if such information has been determined: Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

CCDFS has one prior CPS investigation for this child and her family. On 8/21/2017, a report was received alleging abuse and neglect. Upon conclusion of a requisite investigation the allegations were found unsubstantiated. The family was provided with information regarding community resources and the case was closed 10/15/2017.

H.
