- **A.** Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 11/26/2017.
- **B.** Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child was in physical distress and was brought into a local hospital for treatment. Upon medical assessment, she was determined to be in critical condition.

- D. The date of birth and gender of child: 8/3/2017, Female
- E. The date that the child suffered the fatality or near fatality: 11/26/2017
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
