## Information for Release:

**A. Date of the notification to the child welfare agency of the death of a child:**

CCDFS was notified of the near fatality on 12/08/2017.

**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

CCDFS received a report that the child was transported via ambulance to a local hospital for treatment due to being in physical distress. Upon medical assessment, the child was determined to be in serious condition.

**D. The date of birth and gender of child:** 8/26/2010, Male

**E. The date that the child suffered the fatality or near fatality:** 12/08/2017

**F. The cause of the fatality or near fatality, if such information has been determined:**

The cause of the near fatality is under investigation.

**G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:**

(1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

(2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

(3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;

CCDFS has the following relevant CPS history for this child and/or his family:

5/26/1999 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found substantiated. Information regarding appropriate community resources was provided to the family, and the case was closed.

11/4/1999 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

7/20/2004 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. Appropriate referrals to community resources were provided to the family, and the case was closed.

1/31/2006 – A report was received alleging neglect. Court action was initiated with relevant family members determined to be in need of protection. The allegations in the report were found substantiated. The family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. The court terminated formal supervision on 5/5/2006, and CCDFS closed its case 6/30/2006.

3/12/2007 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

7/2/2007 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found substantiated. Appropriate referrals to community resources were provided to the family, and the case was closed.

2/23/2008 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. Appropriate referrals to community resources and services were provided to the family, and the case was closed.

8/5/2008 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. Appropriate referrals for services were provided to the family, and the case was closed.

12/7/2012 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

4/8/2014 – This report was referred to an outside agency for assessment through the Nevada Department of Health and Human Resources, Differential Response program.

7/12/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

8/10/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

1/22/2015 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

3/29/2017 – A report was received alleging neglect, with additional information received on 3/31/2017. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was provided with information regarding community resources, and the case was closed.

7/3/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding community resources, and the case was closed

10/25/2017 – A report was received alleging neglect. The case remains open.

**H. CCDFS has opened an investigation and is working in conjunction with local law enforcement. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
