**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

On 1/23/2018, CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding a child who was in physical distress. The child was transported to a local hospital and upon medical assessment was determined to be in critical condition.

On 1/24/2018, the child was pronounced deceased.

**D. The date of birth and gender of child:** 3/17/2017, Female

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:** (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

CCDFS has the following relevant prior history for this family:

9/28/2015 – The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded “Information Only”.

9/23/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

- H. CCDFS has opened an investigation and is working in conjunction with local law enforcement. CCDFS will continue to, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
