A. Date of the notification to the child welfare agency of the death of a child: 2/5/2018

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive infant. The infant was transported to a local hospital where she was later pronounced deceased.

- **D.** The date of birth and gender of child: 11/18/2017, Female
- E. The date that the child suffered the fatality or near fatality: 2/5/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or

communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

(2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

CCDFS has one prior CPS investigation for this child and her family. On 11/24/2017, a report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was connected to and accessing community resources and services. They were provided with additional information and brochures based upon their needs and the case was closed 1/18/2018.

H. Whether the agency which provides child welfare services, in response to the fatality or

near fatality: (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS opened an investigation at the time of the fatality incident. Grief and loss brochures, as well as, information for support group resources has been provided to the family. Final disposition of the investigation is pending.
