**A. Date of the notification to the child welfare agency of the death of a child:**

**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

On 3/7/2018, CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding an unresponsive child. The child was transported to a local hospital for treatment, and upon medical assessment, was determined to be in critical condition.

On 3/8/2018, the child was pronounced deceased.

**D. The date of birth and gender of child:** 10/5/2017, Female

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

CCDFS has the following prior CPS history for this child and/or her family:

4/7/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

10/24/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was provided with a community resource guide and the case was closed.

- H.
