A. Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 3/19/2018.

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that child was taken to a local hospital due to being in physical distress. Upon medical assessment the child was determined to be in critical condition. There are reported concerns regarding management of his medical condition.

- D. The date of birth and gender of child: 9/2/2007, Male
- E. The date that the child suffered the fatality or near fatality: 3/19/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.

On 2/23/2017 –A report was received alleging abuse, with additional information received 2/24/2017. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

2/13/2018 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded "Information Only."

H.
