- A. Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 3/23/2018.
- **B.** Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child sustained injuries as a result of a motor vehicle accident in which she was a passenger. The child was transported from the scene of the accident to a local hospital where medical assessment deemed her to be in serious condition.

- **D.** The date of birth and gender of child: 10/22/2016, Female
- E. The date that the child suffered the fatality or near fatality: 3/23/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
