**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

On 3/30/2018, CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call relating to an unresponsive infant. The infant was transported to a local hospital and upon medical assessment was determined to be in critical condition.

On 3/31/2018, the child was pronounced deceased.

**D. The date of birth and gender of child:** 11/5/2017, Female

**E. The date that the child suffered the fatality or near fatality:**

**F. The cause of the fatality or near fatality, if such information has been determined:**

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.
