#### **Information for Release:**

- **A.** Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 4/7/2018; and the fatality on 4/17/2018.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to the local residence of the child's adult caregivers on a 9-1-1 call that the child was in physical distress. The child was transported to a local hospital where he was listed in critical condition.

On 4/17/2018, the child was pronounced deceased.

### **D.** The date of birth and gender of child: 9/1/2016, Male

- **E.** The date that the child suffered the fatality or near fatality: Near fatality: 4/7/2018 Fatality: 4/17/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality/fatality is under investigation. Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or

communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

(2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

(3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;

(4) Whether the agency which provides child welfare services took any other actions concerning the welfare of the child before or at the time of the fatality or near fatality; and

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has no prior CPS history for this child and/or his family.

CCDFS has the following CPS history for the adult caretakers and household where the near fatality incident is alleged to have occurred:

7/12/2013 - A report was received alleging abuse. Court action was initiated and a petition was filed. Upon conclusion of a requisite investigation, the allegations were found substantiated. On 9/20/2013, the court dismissed the petition and returned the household member to the parent; thereby closing the case as to the relevant household member.

7/31/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated and the case was closed.

3/15/2015 – A report was received alleging abuse. Court action was initiated and relevant household members were found to be in need of protection. The allegations in the report were found substantiated. The family was placed under formal supervision and a case plan put in place. Appropriate referrals and services were provided to the family. Referrals dated 10/4/2016, 10/12/2016 and 1/23/2017 were also receiving during the course of the open case and were coded "Information Only." The court terminated jurisdiction on 3/1/2017 and the case closed.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality: (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS opened a case for investigation at the time of the near fatality incident. Family assessment is ongoing. CCDFS will continue to, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
