### Information for Release:

**A. Date of the notification to the child welfare agency of the death of a child:**

CCDFS was notified of the near fatality on 4/18/2018.

**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

On 4/18/2018, emergency responders were dispatched to a local residence on a 9-1-1 call regarding a child who was in physical distress. The child was transported to a local hospital for treatment and upon medical assessment, was determined to be in serious condition. Medical evaluation of the child indicated the child's condition was not consistent with the explanation provided.

**D. The date of birth and gender of child:** 6/25/2017, Male

**E. The date that the child suffered the fatality or near fatality:** 4/18/2018

**F. The cause of the fatality or near fatality, if such information has been determined:**

The cause of the near fatality is under investigation.

- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:** (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;
- (2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;
- (3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;

CCDFS has the following relevant CPS history for this child and/or his family:

12/12/2013 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded “Information Only.”

10/20/2014 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded “Information Only.”

3/3/2016 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

7/18/2016 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded “Information Only.”

2/22/2018 – A report was received alleging neglect, with additional information being received on 3/15/2018. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated, and the case was closed.

- H. CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
