## **Information for Release:**

- A. Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 5/9/2018.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding a child in physical distress. The child was transported to a local hospital and upon medical assessment was determined to be in critical condition. The child was then transferred to another local hospital for a higher level of care.

- **D.** The date of birth and gender of child: 6/8/2016, Male
- E. The date that the child suffered the fatality or near fatality: 5/9/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;
  - (2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;
  - (3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;
  - (4) Whether the agency which provides child welfare services took any other actions concerning the welfare of the child before or at the time of the fatality or near fatality; and
  - (5) A summary of the status of the child's case at the time of the fatality or near fatality, including, without limitation, whether the child's case was closed by the agency which provides child welfare services before the fatality or near fatality and, if so, the reasons that the case was closed.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has the following CPS history for this child and/or his family:

1/7/2009 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

2/8/2010 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

12/10/2012 – A report was received alleging neglect. Court action was initiated and relevant family members were determined to be in need of protection. The allegations in the report were found substantiated. The family was placed under formal supervision and a case plan put in place. During the course of the open case two additional reports were received. On 4/16/2013 a report was received alleging abuse, with allegations being found unsubstantiated. On 7/12/2013 a report was received following the birth of another child. Court action was initiated in this instance and the child was determined to be in need of protection. The allegations were found substantiated. Appropriate referrals and services were provided to the family. CCDFS closed its case on 6/17/2014 with the court terminating wardship.

1/20/2015 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

11/21/2017 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated and the case was closed on 12/12/2017.

## H. Whether the agency which provides child welfare services, in response to the fatality or
