- A. Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 5/29/2018.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child was brought into a local hospital by his adult caregiver after having concerns with him exhibiting signs of physical distress. Upon examination, the child was determined to be in serious condition. Due to the nature of his condition, arrangements were being made to transport him to another hospital for a higher level of treatment.

- **D.** The date of birth and gender of child: 9/18/2017, Male
- E. The date that the child suffered the fatality or near fatality: 5/29/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

CCDFS has the following relevant prior CPS history for this child and/or his family:

6/24/2012 – A report was received alleging neglect. Upon receipt of additional factual information from the mandated reporting source, the report did not warrant an investigation; therefore, the investigation was cancelled.

5/6/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

6/30/2014 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

7/9/2014 – A report was received alleging neglect. Court action was initiated and relevant family members were found to be in need of protection. The report was found substantiated. The family was placed under formal supervision and a case plan was put in place. Appropriate referrals and services were provided to the family. The court terminated wardship on 9/15/2014 and the case closed.

4/12/2016 – A report was received alleging neglect. CCDFS responded to the reported address. Upon appropriate inquiry, information was received that the family no longer resided at the address. CCDFS conducted diligent search efforts to locate the family, including accessing relevant human services databases. Due to unsuccessful attempts to make contact with the family and insufficient information available to support the allegations, the allegations were unsubstantiated and the case closed.

8/2/2017 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

9/18/2017 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

H.
