**A. Date of the notification to the child welfare agency of the death of a child:** 6/7/2018

**B. Location of child at the time of death or near fatality (city/county):** Las Vegas, Clark

**C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**

CCDFS received a report that law enforcement and emergency medical personnel responded to a local apartment complex regarding an unresponsive child who had been pulled from the pool. The family was visiting the apartment complex to attend a pool party with several other families. The child was transported to a local hospital where she was later pronounced deceased. At the time of the report limited factual information was available with regard to the events leading up to the incident.

**D. The date of birth and gender of child:** 10/15/2013, Female

**E. The date that the child suffered the fatality or near fatality:** 6/7/2018

**F. The cause of the fatality or near fatality, if such information has been determined:**

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so:** (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;
