Information for Release:

A. Date of the notification to the child welfare agency of the death of a child:

CCDFS was notified of the near fatality on 7/25/2018.

B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child, who was barely responsive, was transported via ambulance to a local hospital for treatment. Upon medical assessment, the child was determined to be in serious condition.

D. The date of birth and gender of child: 9/17/2014, Female

E. The date that the child suffered the fatality or near fatality: 7/25/2018

F. The cause of the fatality or near fatality, if such information has been determined:

The cause of the near fatality is under investigation.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

(2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

(3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;

(4) Whether the agency which provides child welfare services took any other actions concerning the welfare of the child before or at the time of the fatality or near fatality; and

(5) A summary of the status of the child's case at the time of the fatality or near fatality, including, without limitation, whether the child's case was closed by the agency which provides child welfare services before the fatality or near fatality and, if so, the reasons that the case was closed.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that are related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.)

CCDFS has the following CPS history for this child and/or her family:

9/24/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was referred to appropriate services based upon their needs and the case was closed.

11/20/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, an allegation was found substantiated. The family was referred to ongoing case management and in-home voluntary services.

12/3/2014 – A report was received alleging neglect. At the time of this report, the family was engaged in in-home voluntary services. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

3/27/2015 – A report was received alleging neglect. At the time of this report, the family was engaged in in-home voluntary services. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

4/16/2015 – A report was received alleging abuse and neglect. Court action was initiated with relevant family members being determined to be in need of protection. Allegations in the report were found substantiated. A case plan was put in place and appropriate referrals and services were provided to the family. During the course of the open case, on 7/10/2015, a report was received alleging neglect and another on 9/23/2015 alleging abuse. Upon conclusion of requisite investigation in these instances, the allegations were found unsubstantiated. The court terminated wardship and custody on 9/30/2015 and the case closed.

2/15/2016 – A report was received alleging abuse and neglect. Court action was initiated with relevant family members being determined to be in need of protection. Allegations in the report were found substantiated. A case plan was put in place and appropriate referrals and services were provided to the family. During the course of the open case, reports were received on 1/16/2017 and 2/27/2017 alleging abuse. Upon conclusion of requisite investigations, the allegations in the report were found unsubstantiated. On 2/24/2017 and 2/27/2017 referrals were received whose factual circumstances did not rise to the level of warranting an investigation, and were coded “Information Only”. The court terminated wardship and custody on 6/14/2017 and the case closed.

On 6/24/2017, 5/23/2018 and 5/25/2018 referrals were received with factual circumstances of this referral did not rise to the level of warranting an investigation and was coded “Information Only”.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality: (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
