A. Date of the notification to the child welfare agency of the death of a child: 8/6/2018

B. Location of child at the time of death or near fatality (city/county): Henderson, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding an infant in physical distress. The infant was transported to a local hospital where she was later pronounced deceased. Concerns were noted regarding the adult caretaker and circumstances surrounding the incident.

D. The date of birth and gender of child: 6/14/2018, Female

E. The date that the child suffered the fatality or near fatality: 8/6/2018

F. The cause of the fatality or near fatality, if such information has been determined:
Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

- G. CCDFS has no prior CPS history for this child and/or her family.
