- **A.** Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 9/1/2018.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to a local apartment complex on a 9-1-1 call regarding a near drowning. The child had been pulled from a hot tub and CPR performed. The child was transported to a local hospital where he was determined to be in serious condition.

- D. The date of birth and gender of child: 7/17/2015, male
- E. The date that the child suffered the fatality or near fatality: 9/1/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: No maltreatment was found to be a factor in this near fatality incident.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or

communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

(2) Whether the agency which provides child welfare services provided any child welfare services to the child or to a member of the child's family or household before or at the time of the fatality or near fatality;

(3) Whether the agency which provides child welfare services made any referrals for child welfare services for the child or for a member of the child's family or household before or at the time of the fatality or near fatality;

CCDFS has the following CPS history for this child and/or family:

10/20/2013 – The factual circumstances of this referral did not rise to the level of warranting an investigation and was coded "Information Only".

7/18/2015 - A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

10/18/2016 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

12/10/2017 – Two referrals were received regarding the same incident and alleged neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality: (1) Has provided or intends to provide child welfare services to the child or to a member of the child's family or household; and (2) Has made or intends to make a referral for child welfare services for the child or for a member of the child's family or household; and (3) Has taken or intends to take any other action concerning the welfare and safety of the child or any member of the child's family or household.

CCDFS has concluded its investigation and family assessment. The investigation found no evidence to support that the near fatality was the result of maltreatment and the child has been assessed as safe. The family was provided with a list of community resources and information based upon their needs. No further CPS intervention or services has been deemed necessary and the case has been closed.
