C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child presented at a local hospital on 9/2/2018 due to being in physical distress. After receiving treatment, the child was discharged home to his parent. On 9/3/2018, the child was transported to the same hospital via ambulance after he was found unresponsive while in the care of another adult caregiver. The child was transferred to another local hospital for specialized treatment and listed in critical condition.

On 9/5/2018, the child was pronounced deceased.

D. The date of birth and gender of child: 10/30/2017, Male

E. The date that the child suffered the fatality or near fatality:

F. The cause of the fatality or near fatality, if such information has been determined:

Release of the cause of the near fatality/fatality will remain pending until receipt of official coroner documentation.

CCDFS has the following relevant CPS history for this family:

CCDFS opened a case for investigation and family assessment at the time of the fatality. Final disposition of the investigation is pending while family assessment remains ongoing. CCDFS will, as deemed appropriate, continue to provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
