- **A.** Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 11/5/2018.
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that emergency medical services responded to a local residence on a 9-1-1 call regarding a child who was in physical distress. The child was transported to a local hospital for treatment and was determined to be in serious condition. There were reported concerns regarding the circumstances surrounding the child's condition.

- **D.** The date of birth and gender of child: 4/28/2018, Female
- E. The date that the child suffered the fatality or near fatality: 11/5/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.

- G.
