- **A.** Date of the notification to the child welfare agency of the death of a child: CCDFS was notified of the near fatality on 12/28/2018.
- **B.** Location of child at the time of death or near fatality (city/county): Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that the child was brought into a local medical care center by his parent. Medical evaluation indicated the child was in need of specialized treatment and the child was transported to a local hospital. Medical evaluation of the child also raised concern that the child's condition did not appear consistent with the explanation provided. At the time of the report, the child was determined to be in serious condition.

- D. The date of birth and gender of child: 9/14/2017, Male
- E. The date that the child suffered the fatality or near fatality: 12/28/2018
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so: (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

CCDFS has the following prior CPS history for this child and/or his family:

6/28/2010 - A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated. The family was offered services, however, they declined. Information regarding community resources was provided to the family, and the case was closed.

8/24/2013 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded "Information Only."

9/13/2013 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

2/16/2018 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

6/14/2018 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded "Information Only."

7/1/2018 – The factual circumstances of this report did not rise to the level of warranting an investigation and was coded "Information Only."

H. CCDFS opened a case for investigation. Family assessment is ongoing with appropriate referrals and services being provided as assessment dictates. CCDFS will continue to, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child and/or relevant members of the child's family or household.
