INFORMATION FOR RELEASE

A. Date of the notification to the child welfare agency of the death of a child:

10/8/2019. At the time of the initial notification, no abuse or neglect was indicated. On 10/31/2019, additional information was received indicating the death of the child was due to maltreatment.

C. A summary of the report of abuse or neglect and a factual description of the contents of the report: CCDFS received a report that, on 10/8/2019, the mother and her six-year-old child were involved in home fire and were deceased.

A public disclosure is being completed based on the nature of the event and the child being deceased due to the actions of an adult caregiver. No formal CCDFS investigation has been opened as the adult caregiver responsible for the child at the time of the incident is deceased.

CCDFS has the following prior history of the child and family:

3/25/2018 - A referral was received and coded "Information Only".

3/26/2018 – Two referrals, each from a different reporting source were received and coded "Information Only".

4/3/2018 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

5/1/2019 - A referral was received and coded "Information Only".

5/14/2019 – Two referrals, each from a different reporting source were received and coded "Information Only".

5/16/2019 – A report was received alleging abuse and neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.
