B. Location of child at the time of death or near fatality (city/county):

Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCDFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding an unresponsive infant. The infant was transported to a local hospital where he was pronounced deceased shortly after arrival. At the time the report was received, the cause of the infant's death was not known.

D. The date of birth and gender of child:

7/21/2019, Male

E. The date that the child suffered the fatality or near fatality:

11/16/2019

F. The cause of the fatality or near fatality, if such information has been determined:

Release of the cause of the fatality will remain pending until receipt of official coroner documentation.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family:

6/4/2018 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

9/22/2018 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

7/9/2019 – A report was received alleging neglect. During the course of the open case, a report was received on 7/12/2019 alleging of abuse and neglect, and another report was received on 9/5/2019 alleging neglect. Upon conclusion of requisite investigations, the allegations in each report were found unsubstantiated. Additionally, two referrals were received on 7/12/2019 and 7/27/2019 that were coded "Information Only". Based upon assessment, the family was provided with services and referrals to appropriate community resources. This case remains open for ongoing family assessment.

CCDFS has the following prior CPS history for a member of the household, that is not related to the child who is the subject of the disclosure:

7/31/2014 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegations were found unsubstantiated.

4/17/2015 – A report was received alleging neglect. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...
