CCDFS has the following prior CPS history for this child or member of the child's family or household:

2/1/2013 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated. The family was referred to an appropriate community resource and the case was closed.

3/4/2019 – A report was received alleging neglect. A referral was also received this date and was coded "Information Only". Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

6/7/2019 - A referral was received and was coded "Information Only".

8/28/2019 – A report was received alleging abuse. Upon conclusion of a requisite investigation, the allegation was found unsubstantiated.

CCDFS opened a case for investigation and family assessment. Services and referrals are being provided as assessment dictates.
